1. Aims

The aims of relationships and sex education (RSE) at our school are to:

- › Provide a framework in which sensitive discussions can take place
- › Prepare pupils for puberty, and give them an understanding of sexual development and the importance of health and hygiene
- › Help pupils develop feelings of self-respect, confidence and empathy
- › Create a positive culture around issues of sexuality and relationships
- › Teach pupils the correct vocabulary to describe themselves and their bodies

St Egwin's is a school with a Christian heart where RSE is taught through the school's core values of; love, respect and endeavor. Ensuring the dignity of all and the uniqueness of each pupil, celebrated and appreciated.

RSE is lifelong learning about physical, sexual, moral and emotional development. It is about the understanding of the importance of stable and loving relationships, respect, love, joy, endeavour and care, for family life. It involves acquiring information, developing skills and forming positive beliefs, values and attitudes informed by the schools Church of England ethos. The lessons are planned to increase pupils self-awareness and self-help along with independence to grow resilience.

For Church schools, RSE is about the emotional, social and physical aspects of growing up, healthy relationships, sex, human sexuality and sexual health. It is also about the spiritual and moral aspects of relationships within a context of a Christian vision for the purpose of life." (Church of England Education Office Response to a Call for Evidence on RSE Curriculum p1)

2. Statutory requirements

As a maintained school we must provide relationships and health education to all pupils as per section 34 of the Children and Social work act 2017.

However, we are not required to provide sex education to primary age pupils but we do need to teach the elements of sex education contained in the science curriculum. However, we chose to teach some aspects of the sex education to each of our year groups as set out in this policy.

In teaching RSE, we must have regard to guidance issued by the secretary of state as outlined in section 403 of the Education Act 1996.

3. Policy development

This policy has been developed in consultation with staff, pupils and parents. The consultation and policy development process involved the following steps:

1. Review – a member of staff or working group pulled together all relevant information including relevant national and local guidance
2. Staff consultation – all school staff were given the opportunity to look at the policy and make recommendations
3. Parent/stakeholder consultation – parents and any interested parties were invited to attend a meeting about the policy
4. Pupil consultation – we investigated what exactly pupils want from their RSE
5. Ratification – once amendments were made, the policy was shared with governors and ratified.

4. Definition

RSE is about the emotional, social and cultural development of pupils, and involves learning about relationships, sexual health, sexuality, healthy lifestyles, diversity and personal identity.

RSE involves a combination of sharing information, and exploring issues and values.

RSE is not about the promotion of sexual activity.

5. Curriculum

Our curriculum is set out as per Appendix 1 but we may need to adapt it as and when necessary.

We have developed the curriculum in consultation with parents, pupils and staff, considering the age, needs and feelings of pupils. If pupils ask questions outside the scope of this policy, teachers will respond in an appropriate manner so they are fully informed and don't seek answers online.

Primary sex education is not compulsory but the school has decided to cover the additional content on sex education to meet the needs of your pupils.

Year 6 sex education will focus on:

- Preparing boys and girls for the changes that adolescence brings
- How a baby is conceived and born

For more information about our curriculum, see our curriculum map in Appendix 1.

The compulsory science curriculum will be taught as:

Year 6 Science: Animals, including humans

- Describe the changes as humans develop to old age. A timeline indicating the growth and development of humans and the changes experienced in puberty.
- Research the gestation periods of other animals and comparing them with humans.

Year 8 Science: Reproduction

- Reproduction in humans (as an example of a mammal), including structure and function of the male and female reproductive systems, menstrual cycle, gametes, fertilisation, gestation and birth, to include the effect of maternal lifestyle on the foetus through the placenta.
- Reproduction in plants.

6. Delivery of RSE

RSE is taught within the personal, social, health and economic (PSHCE) education curriculum. Biological aspects of RSE are taught within the science curriculum, and other aspects are included in religious education (RE). We have chosen, with other local schools, to use a selection of national resources. These include the new adapted Medway Council and the PSHE Association's RSE course; the NSPCC relationship lessons; Collins Education and some public health England resources. These are all using each organisations specialist knowledge and experience that has helped shape the work. We believe these resources are based on current best practice.

Pupils also receive stand-alone sex education sessions delivered by a trained PSHCE teacher.

Year 6 Relationships education focuses on teaching the fundamental building blocks and characteristics of positive relationships including:

- Families and people who care for me
- Caring friendships
- Respectful relationships

- › Online relationships
- › Being safe
- › Conception and birth (Sex Education)

Year 7 and 8 RSE focuses on giving young people the information they need to help them develop healthy, nurturing relationships of all kinds including:

- › Families
- › Respectful relationships, including friendships
- › Online and media
- › Being safe
- › Intimate and sexual relationships, including sexual health

For more information about our RSE curriculum, see Appendices 1 and 2.

These areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBT parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers).

7. Roles and responsibilities

7.1 The governing board

The governing board will approve the RSE policy, and hold the headteacher to account for its implementation.

7.2 The headteacher

The headteacher is responsible for ensuring that RSE is taught consistently across the school, and for managing requests to withdraw pupils from [non-statutory/non-science] components of RSE (see section 8).

7.3 Staff

Staff are responsible for:

- › Delivering RSE in a sensitive way
- › Modelling positive attitudes to RSE
- › Monitoring progress
- › Responding to the needs of individual pupils
- › Responding appropriately to pupils whose parents wish them to be withdrawn from the [non-statutory/non-science] components of RSE

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the headteacher.

Ms R Croft (Head of PSHCE) is responsible for teaching and training the other PSHCE staff involved in teaching RSE in St Egwin's CE Middle School.

7.4 Pupils

Pupils are expected to engage fully in RSE and, when discussing issues related to RSE, treat others with respect and sensitivity. The uniqueness of the pupils and their needs are appreciated and inform the

curriculum and the adaptations to make it appropriate for all pupils age, stage and need for their future options and choices.

“The hallmark of authentic, life-giving relationships is recognition of the sacredness of the other so that all are welcomed wholeheartedly and with reverence. Each person in all their unique difference should be able to thrive, irrespective of physical appearance, gender, race, religion, ethnicity, socio-economic background, academic ability, disability, sexual orientation or gender identity.” (Valuing All God’s Children, Church of England 2019 p11)

8. Parents’ right to withdraw

All Parents/carers will receive a letter at the beginning of the academic year about the RSE curriculum (Appendix 4), a follow up parent mail will be sent a half-term before the specific pupils will be taught RSE. Year 6 parents do not have the right to withdraw their children from relationships education. Parents have the right to withdraw their children from the [non-statutory/non-science] components of sex education within RSE.

Year 7 and 8 parents have the right to withdraw their children from the [non-statutory/non-science] components of sex education within RSE up to and until 3 terms before the child turns 16. After this point, if the child wishes to receive sex education rather than being withdrawn, the school will arrange this. Requests for withdrawal should be put in writing using the form found in Appendix 3 of this policy and addressed to the headteacher.

A meeting will be arranged with the Head of PSHCE and Head of Welfare to discuss the completion of the withdrawal form and the detail of content the pupils can be withdrawn from. If a parent continues to want withdrawal the headteacher will acknowledge receipt of the form and take appropriate action. A copy of withdrawal requests will be placed in the pupil’s educational record. Alternative work will be given to pupils who are withdrawn from sex education.

9. Training

Staff are trained on the delivery of RSE as part of their PSHCE teaching training and are monitored within the calendar for safeguarding training. Head of PSHCE will be responsible for informing the headteacher of the training requirements of staff training for RSE.

The headteacher will also invite visitors from outside the school, such as school nurses or sexual health professionals, to provide support and training to staff teaching RSE.

10. Monitoring arrangements

The delivery of RSE is monitored by Ms R Croft (Head of PSHCE) through: yearly monitoring arrangements within school by; yearly pupil voice, lesson assessments and a yearly review.

Working with PHHS to ensure the content is complete for Key Stage 3 requirements and evaluating best practice, through external training.

Pupils’ development in RSE is monitored by class teachers as part of our internal assessment systems.

This policy will be reviewed by Ms R Croft (Head of PSHCE), annually. At every review, the policy will be approved by Ms C Gordon (Assistant Headteacher – DSL/Pupil welfare), Mrs J Daniels-Stretch (Safeguarding Governor), Mr S Plane (Interim Headteacher) and Mrs P Paterson (Chair of Governors).

Appendix 1: Curriculum map

Relationships and sex education curriculum map

Year Six

Lesson 1 What is puberty?

We are learning the key facts about puberty and the changing adolescent body, including physical changes.

Lesson 2 Changes in emotions

We are learning key facts about puberty and the changing adolescent body, including emotional changes.

Lesson 3 The menstrual cycle

We are learning menstrual wellbeing, including the key facts about the menstrual cycle.

Lesson 4 What happens to boys?

We are learning the key facts about puberty and the changing adolescent body, boys.

Lesson 5 What is love? Positive and healthy relationships

We are learning that families are important for children growing up because they can give love, security and stability.

Lesson 6 Sexual Attraction

We are learning that each person's body belongs to them, and the differences between appropriate and inappropriate or unsafe physical, and other, contact.

Lesson 7 Consent

We are learning about practical steps they can take in a range of different contexts to improve or support respectful relationships. How to report concerns or abuse, and the vocabulary and confidence needed to do so.

Lesson 8 Conception – How babies are made

We are learning that each person's body belongs to them, and the differences between appropriate and inappropriate or unsafe physical, and other, contact. Learning about the stages of pregnancy and how a baby is conceived.

Lesson 9 More about babies and their families.

We are learning that others' families, either in school or in the wider world, sometimes look different from their family, but that they should respect those differences and know that other children's families are also characterised by love and care.

Year Seven

Lesson 1 Puberty

We are learning about how the emotions are affected by puberty, how this may affect relationships and how to manage this.

Lesson 2 Menstrual Wellbeing

We are learning about menstrual (period) wellbeing.

Lesson 3 Healthy Relationships and Changing Friendships

We are learning about the qualities of healthy and unhealthy relationships.

Lesson 4 Healthy Online Friendships

We are learning about the differences between online and offline friendships, explore some of the risks and benefits of this communication.

Lesson 5 Managing Conflict and Hurtful Behaviour

We are learning skills to manage relationship conflict in families

Lesson 6 Introduction to Consent

We are learning about what consent means, both legally and ethically, and what it looks like in practice.

Year Eight

Lesson 1 Relationship Values

We are learning to develop realistic and healthy relationship values and expectations.

Lesson 2 Influences on Relationship Expectations

We are learning how to challenge unrealistic relationship expectations

Lesson 3 Sexualised media and safe online relationships

We learn how about the risks of online relationships and how pupils can maintain safer online relationships

Lesson 4 Sexual Orientation and Gender Identity

We are learning to understand and respect the spectrum of gender identities and sexual orientations.

Lesson 5 Harassment and harmful sexual behaviour

We explore and empower pupils to identify potential grooming and manage the challenges of harmful online behaviour.

Lesson 6 Consent – Avoiding Assumptions

We are learning about common assumptions related to consent and how to challenge these.

Lesson 7 Introduction to Contraception

We are learning about how and why different contraceptives are used.

Caring friendships	<ul style="list-style-type: none"> • How important friendships are in making us feel happy and secure, and how people choose and make friends • The characteristics of friendships, including mutual respect, truthfulness, trustworthiness, loyalty, kindness, generosity, trust, sharing interests and experiences and support with problems and difficulties • That healthy friendships are positive and welcoming towards others, and do not make others feel lonely or excluded • That most friendships have ups and downs, and that these can often be worked through so that the friendship is repaired or even strengthened, and that resorting to violence is never right • How to recognise who to trust and who not to trust, how to judge when a friendship is making them feel unhappy or uncomfortable, managing conflict, how to manage these situations and how to seek help or advice from others, if needed

Respectful relationships	<ul style="list-style-type: none"> • The importance of respecting others, even when they are very different from them (for example, physically, in character, personality or backgrounds), or make different choices or have different preferences or beliefs • Practical steps they can take in a range of different contexts to improve or support respectful relationships • The conventions of courtesy and manners • The importance of self-respect and how this links to their own happiness • That in school and in wider society they can expect to be treated with respect by others, and that in turn they should show due respect to others, including those in positions of authority • About different types of bullying (including cyberbullying), the impact of bullying, responsibilities of bystanders (primarily reporting bullying to an adult) and how to get help • What a stereotype is, and how stereotypes can be unfair, negative or destructive • The importance of permission-seeking and giving in relationships with friends, peers and adults
Online relationships	<ul style="list-style-type: none"> • That people sometimes behave differently online, including by pretending to be someone they are not • That the same principles apply to online relationships as to face-to face relationships, including the importance of respect for others online including when we are anonymous • The rules and principles for keeping safe online, how to recognise risks, harmful content and contact, and how to report them • How to critically consider their online friendships and sources of information including awareness of the risks associated with people they have never met • How information and data is shared and used online
Being safe	<ul style="list-style-type: none"> • What sorts of boundaries are appropriate in friendships with peers and others (including in a digital context) • About the concept of privacy and the implications of it for both children and adults; including that it is not always right to keep secrets if they relate to being safe • That each person's body belongs to them, and the differences between appropriate and inappropriate or unsafe physical, and other, contact • How to respond safely and appropriately to adults they may encounter (in all contexts, including online) whom they do not know • How to recognise and report feelings of being unsafe or feeling bad about any adult • How to ask for advice or help for themselves or others, and to keep trying until they are heard • How to report concerns or abuse, and the vocabulary and confidence needed to do so • Where to get advice e.g. family, school and/or other sources

Families	<ul style="list-style-type: none"> • That there are different types of committed, stable relationships • How these relationships might contribute to human happiness and their importance for bringing up children • What marriage is, including their legal status e.g. that marriage carries legal rights and protections not available to couples who are cohabiting or who have married, for example, in an unregistered religious ceremony • Why marriage is an important relationship choice for many couples and why it must be freely entered into • The characteristics and legal status of other types of long-term relationships • The roles and responsibilities of parents with respect to raising of children, including the characteristics of successful parenting • How to: determine whether other children, adults or sources of information are trustworthy: judge when a family, friend, intimate or other relationship is unsafe (and to recognise this in others' relationships); and, how to seek help or advice, including reporting concerns about others, if needed
Respectful relationships, including friendships	<ul style="list-style-type: none"> • The characteristics of positive and healthy friendships (in all contexts, including online) including: trust, respect, honesty, kindness, generosity, boundaries, privacy, consent and the management of conflict, reconciliation and ending relationships. This includes different (non-sexual) types of relationship • Practical steps they can take in a range of different contexts to improve or support respectful relationships • How stereotypes, in particular stereotypes based on sex, gender, race, religion, sexual orientation or disability, can cause damage (e.g. how they might normalise non-consensual behaviour or encourage prejudice) • That in school and in wider society they can expect to be treated with respect by others, and that in turn they should show due respect to others, including people in positions of authority and due tolerance of other people's beliefs • About different types of bullying (including cyberbullying), the impact of bullying, responsibilities of bystanders to report bullying and how and where to get help • That some types of behaviour within relationships are criminal, including violent behaviour and coercive control • What constitutes sexual harassment and sexual violence and why these are always unacceptable • The legal rights and responsibilities regarding equality (particularly with reference to the protected characteristics as defined in the Equality Act 2010) and that everyone is unique and equal

Online and media	<ul style="list-style-type: none"> • Their rights, responsibilities and opportunities online, including that the same expectations of behaviour apply in all contexts, including online • About online risks, including that any material someone provides to another has the potential to be shared online and the difficulty of removing potentially compromising material placed online • Not to provide material to others that they would not want shared further and not to share personal material which is sent to them • What to do and where to get support to report material or manage issues online • The impact of viewing harmful content • That specifically sexually explicit material e.g. pornography presents a distorted picture of sexual behaviours, can damage the way people see themselves in relation to others and negatively affect how they behave towards sexual partners • That sharing and viewing indecent images of children (including those created by children) is a criminal offence which carries severe penalties including jail • How information and data is generated, collected, shared and used online
Being safe	<ul style="list-style-type: none"> • The concepts of, and laws relating to, sexual consent, sexual exploitation, abuse, grooming, coercion, harassment, rape, domestic abuse, forced marriage, honour-based violence and FGM, and how these can affect current and future relationships • How people can actively communicate and recognise consent from others, including sexual consent, and how and when consent can be withdrawn (in all contexts, including online)

Intimate and sexual relationships, including sexual health	<ul style="list-style-type: none"> • How to recognise the characteristics and positive aspects of healthy one-to-one intimate relationships, which include mutual respect, consent, loyalty, trust, shared interests and outlook, sex and friendship • That all aspects of health can be affected by choices they make in sex and relationships, positively or negatively, e.g. physical, emotional, mental, sexual and reproductive health and wellbeing • The facts about reproductive health, including fertility and the potential impact of lifestyle on fertility for men and women • That there are a range of strategies for identifying and managing sexual pressure, including understanding peer pressure, resisting pressure and not pressurising others • That they have a choice to delay sex or to enjoy intimacy without sex • The facts about the full range of contraceptive choices, efficacy and options available • The facts around pregnancy including miscarriage • That there are choices in relation to pregnancy (with medically and legally accurate, impartial information on all options, including keeping the baby, adoption, abortion and where to get further help) • How the different sexually transmitted infections (STIs), including HIV/AIDs, are transmitted, how risk can be reduced through safer sex (including through condom use) and the importance of and facts about testing • About the prevalence of some STIs, the impact they can have on those who contract them and key facts about treatment • How the use of alcohol and drugs can lead to risky sexual behaviour • How to get further advice, including how and where to access confidential sexual and reproductive health advice and treatment

You will be aware that, as a part of your child's educational experience at St Egwin's CE Middle School, we aim to promote personal wellbeing and development through a comprehensive taught programme of Personal, Social, Health and Economic (PSHE) and Citizenship education that gives young people the knowledge, understanding, attitudes and practical skills to live healthy, safe, productive and fulfilled lives, both now and in the future.

I am writing to let you know that for year 8, during the second half of the spring term, your child's class will be taking part in lessons which will focus on Relationships and Sex Education (RSE). As students' progress through school the topics will be delivered at age appropriate level. Lessons will include students learning (from year 6 to year 8): Healthy and unhealthy relationships, different types of families, managing online relationships, menstruation and puberty, self-esteem and romance, consent, managing conflict, sexual orientation and gender identity, marriage and divorce, body image and gender stereotyping, parenting skills, relationship myths, relationship/ domestic abuse, forced marriage, contraception, sexually transmitted infections, sharing explicit images ('nudes and semi-nudes'), the effects of pornography on relationship expectations
